Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

Methods and materials for containment and cleaning up

Small spill

Section 7. Handling and storage

Precautions for safe handling

Protective measures

Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use. Keep away from acids. : Store in accordance with local regulations. Keep container tightly closed and sealed until ready for use. Containers that have been opened must be carefully resealed and kept upright to prevent leakage. Do not store in unlabeled containers. Use appropriate containment to avoid environmental contamination.
